# Item 2 - President / Secretary Report

This year has been both interesting and a challenge for the Club.

A big thank you to all our members for their patience and tolerance while we carried out refurbishment to the gents' and the ladies' toilets, fitted fresh flooring to the upper pantry, smartened the length of wooden fencing at the bowling green and generally started adding some finishing touches to the decorated Reading Room.

Specific thanks go to our steward John Haefner, and many members for their donations of items such as the outstanding table in Reading Room and to the club's Fabric Fund. The Sunday lunch 'Bonus Ball' sheets continue to be popular – which further adds to the opportunities to make small improvements for the benefit of all users. Our thanks too go to Jim and Pat Gifford for stepping in to look after the book lending area after the passing of John Dockerill.

The annual accounts (to 31 March 2016) show a deficit, significantly produced by last year's repairs and renewals of £9½K. It is understood that such hefty renewals and repairs will not be required for many years, such as the outside painting, and the previously outstanding electrical inspections. Damage to the harling at the front of the building should receive attention this year to prevent water ingress.

The club may have the opportunity to raise funds from sale of the disused courtyard, reserving access for maintenance and roof/gutter repairs etc., which is a proposition I recommend the membership to support.

Council has continued with energy saving measures such as starting to install secondary glazing. The club website, Facebook and email allows for economically viable communication giving us a significant saving. The now very high postage costs have meant communication with members continues to be as posted up in the club but also by our club website and email rather than by post.

The Club's Events and Functions continue to be well-attended, particularly popular are the Snooker Nights (thanks to Billy French) and the Games Nights (thanks to Brian Skene) and Quiz nights. Different types of social functions demonstrate the evolving style of club use. The entertainer at the early summer BBQ is returning at Hogmanay by popular request.

In short, the Banff Town and County Club remains steady – due to the support of our members.

As always, thanks are due to John Haefner our Steward and each of his staff, and to all my colleagues on Council, for their energy, attention and dedication while we manage the Club's affairs.

# Item 5 – Hon. Treasurer's Report

I am unsure as to the number of members at the end of the financial year – I can tell you at the present time there are 165 paid members. There are 41 members with outstanding subscriptions. 22 members have not renewed their subscriptions mainly due to age and no longer able to attend or moved away from the area. However there have also been 15 new members since the end of the last financial year.

The financial statement attached shows a loss after tax of £3198.00 compared to a profit last year. There was considerable expenditure in this last financial year due to upgrade and repairs to the building as described in the chairman/secretary report. If this expenditure was removed there would have been a healthy profit.

There has been little expenditure in many years on improving or renovating the building and that is now becoming evident.

The refurbishment of the reading room was covered by insurance and settlement was made outwith with 2015/16 financial year. However, all the other work carried out, not covered by insurance, is included.

The stock-take at the end of the financial year and a recent a mid-year stock take and profit margin assessment is showing the bar to be running at a 51% profit margin.

Income to the club relies on membership and the bar takings. Each event held at the club obviously increases the bar takings. Any members with ideas or recommendations for functions/or events that could be held at the club would be warmly received by the committee.

It was hoped to have the AGM earlier this year but due to a bereavement at Atholl Scott our accounts were delayed. Hopefully next year the AGM will be earlier.

The club is in a sound financial position but depends on its continued and increasing membership and bar takings to survive.
